AN ORDINANCE AMENDING THE CITY ZONING ORDINANCE OF THE CITY OF CLARKSVILLE, TENNESSEE, EXTENDING THE MADISON STREET CORRIDOR URBAN DESIGN OVERLAY DISTRICT UP HIGHWAY 76 CONNECTOR TO INTERSTATE 24 AND OTHER ASSOCIATED CHANGES.

WHEREAS the City Council of Clarksville, Tennessee passed Resolution 32-2019-20 on December 5, 2019 titled "A RESOLUTION REQUESTING THE REGIONAL PLANNING COMMISSION DIRECTOR AND STAFF TO PERFORM A STUDY WITH REGARD TO CREATION OF A DESIGN OVERLAY DISTRICT FOR SR 76/DR MARTIN LUTHER KING, JR. PARKWAY", AND

WHEREAS right after its passage the COVID 19 pandemic disrupted city and county functions for almost two years and this resolution went unanswered, AND

WHEREAS the Regional Planning Commission will be updating the entire zoning ordinance over the next 18 months and needs to close out all open business, AND

WHEREAS the Regional Planning Commission mailed each property owner in the newly proposed overlay a notice and held a public workshop on August 22, 2024, AND

WHEREAS overlay design districts can help promote uniform development standards in areas that are growing and redeveloping

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CLARKSVILLE, TENNESSEE,

That the following amendments are hereby made to the Clarksville City Zoning Ordinance:




